2010 Sales Policies and Commercial Terms & Conditions of Sale

- 1) **Ordering:** Orders may be placed by phone, fax, email or mail.
- 2) **Minimum Order:** Enchantment Motor Sports, LLC (Love Handles) requires a minimum order of one (1) unit, which will be configured according to your specifications.
- 3) **Sales:** Enchantment Motor Sports, LLC (Love Handles) sells through authorized motorcycle/trike dealerships, accessory and service stores. If there is a dealer within 25 miles of an authorized dealership, Enchantment Motor Sports will direct the consumer to the dealership or store, but reserves the right to sell directly to the consumer at full MSRP plus freight.
- 4) **Pricing:** Enchantment Motor Sports reserves the right to change prices without notice. We will, however, make every effort to notify dealers of impending price changes.
- 5) **Payment:** Orders will be charged to your Visa, MasterCard, Discover or American Express Card.
- 6) **Shipping:** Unless otherwise requested all orders will be shipped FedEx Ground and billed to you.
- 7) **Internet/Mail Order Sales:** Your internet/mail order sales cannot be more than 5% below MSRP and dealer must obtain prior Enchantment Motor Sports authorization to do so. Contact Bill Freer at 505-414-9676 for conditions and authorization to sell on the internet or via mail order advertising.
- 9) **Damages:** All goods damaged in transit are the sole responsibility of the carrier. Any claims must be filed with carrier upon delivery.
- 10) **Warranty:** Enchantment Motor Sports LLC (Love Handles) motorcycle armrests are covered by a limited warranty for the life of the motorcycle while owned by the original purchaser of the armrests. The warranty is limited to the repair or replacement at the option of Enchantment Motor Sports, LLC.
This warranty is expressly in lieu of all other warranties and implied warranties of merchantability or fitness for purpose. Enchantment Motor Sports, LLC shall not be liable for any form of incidental or consequential damages of any kind. Please obtain a Return Material Authorization (RMA) number from Enchantment Motor Sports before shipping product directly (freight pre-paid) to Enchantment Motor Sports, LLC for inspection. - 11) **Returns:** All sales are considered final unless there are defects in manufacturing or customer dissatisfaction. Returns cannot be made without a RMA number. Returns must be sent via the least expensive means and prepaid and include all original packaging.

- 13) **Document Precedence:** This agreement supersedes and replaces any previously signed agreement. Enchantment Motor Sports, LLC (Love Handles) reserves the right to change this agreement at any time (including by amending any of its terms, adding new terms or deleting or modifying existing terms) on at least 10 calendar days prior written notice.
